HOLD HARMLESS AGREEMENT: It is expressly understood and agreed that the Renter shall hold the City of Manning, SC harmless from any accident and/or injury as result of, or in connection with the use of the above referenced property owned by the City of Manning, SC.

GENERAL RULES:

- Parking is permitted in designated spaces only.
- Grills of any kind ARE NOT allowed.
- Inflatables are NOT permitted.
- Leave the shelter and surrounding area as you found it.
- All trash on the grounds must be removed.
- Decorations are allowed but must be attached using tape, ribbon, or soft wire and must be removed prior to leaving. Tacks, staples, or nails are not allowed.
- NO ALCOHOLIC BEVERAGES ALLOWED.
- SMOKING IS PROHIBITED.
- Golf carts are PROHIBITED inside the park.
- Activities must take place between the hours of 9AM to 8PM
- Live entertainment is not permitted without prior consent.
- Cancellation is required within 7 days of scheduled event in order for refunds to be considered.
- The person reserving the shelter is accountable for observance of the above conditions and conduct of guests with consideration to the surrounding residential area.
